



Blackpool International - Passenger Car Parks

- This is the Passenger Car Park for the sole use of passengers of Blackpool International
- All passengers of Blackpool International are entitled to 15 days' free car parking in the Passenger Car Parks
- Passengers using the Passenger Car Parks should retain the ticket obtained from the machine at the entry barrier
- In order to release your vehicle from a Passenger Car Park, you must validate your ticket at a pay machine located in the Arrivals Hall on your return from holiday. Passengers will be required to pay:
 - £NIL for vehicles parked for 0-15 days; and
 - £10 for each day or part thereof for vehicles parked for more than 15 days
- Any person who is not a passenger of Blackpool International shall be required to pay £28 per day or part thereof for each day that their vehicle is parked in the Passenger Car Parks
- Blue badge holders and any person who is not a passenger of Blackpool International should park their vehicle in the "Pay to Park" Car Park located at the front of the terminal building
- Unauthorised parking may result in a vehicle being clamped or removed

THESE ARE THE TERMS AND CONDITIONS FOR THE USE OF PASSENGER CAR PARKING FACILITIES AT BLACKPOOL INTERNATIONAL. PASSENGERS ARE REQUESTED TO READ CAREFULLY THE TERMS AND CONDITIONS OF ENTRY TO AND USE OF THE PASSENGER CAR PARKS AND TO FOLLOW WHERE APPLICABLE THE PROCEDURES RECOMMENDED

General

1. Blackpool Airport Limited (**BAL**) provides Passenger Car Parks to passengers of Blackpool International to park their vehicles
2. For the purposes of these terms and conditions, a "passenger" shall mean a person who has a confirmed reservation on a flight departing from Blackpool International

Fees and Charges

3. A passenger may park one vehicle in a Passenger Car Park for up to 15 days free of charge
4. In order to release a vehicle from a Passenger Car Park, the passenger must pay for their parking and validate their ticket at a pay machine located in the

Arrivals Hall before returning to their vehicle. Passengers will be required to pay:

- i. £NIL for vehicles parked for 0-15 days; and
 - ii. £10 for each day or part thereof for vehicles parked for more than 15 days
5. Non-passengers will be charged at the rate of £28 per day or part thereof for each day that their vehicle is parked in a Passenger Car Park
6. Any person, who parks their vehicle in a Passenger Car Park for more than 15 days, is liable to pay the advertised charges in full:
 - i. £10 per day or part thereof for passengers; and
 - ii. £28 per day or part thereof for non-passengers
7. In default of production of a ticket validated in the machines in the Arrivals Hall allowing the release of a vehicle from a Passenger Car Park, BAL reserves the right to charge the owner £28 per day or part thereof for the duration of the time that the vehicle is parked in the Passenger Car Park and BAL shall determine the length of time that the vehicle has been parked in the Passenger Car Park (acting reasonably).
8. Any person who cannot produce a validated ticket allowing release of a vehicle from a Passenger Car Park who can evidence to the reasonable satisfaction of BAL (by producing relevant travel documentation) that he/she is a passenger of Blackpool International shall not be required to pay any car parking charges for the first 15 days that their vehicle is parked in a Passenger Car Park and shall be charged £10 per day or part thereof for any additional days

Security

9. BAL cannot guarantee the security of vehicles and their contents. BAL does not accept liability for any damage to or loss of vehicles or their contents which is the result of acts or omissions outside the reasonable control of BAL or its contractors
10. Vehicles must be parked within the marking of a designated space (where spaces are demarcated). BAL reserves the right to nominate specific bays for designated use

Waiver of Liability

11. BAL shall not be liable in respect of any death, personal injury, loss or damage sustained by any person entering a car park howsoever the same may be caused, unless caused by the negligence of BAL

Damage and Indemnity

12. Any damage to the property of a third party or BAL should be reported directly to a member of staff. Any damage to or theft of or from a vehicle parked in the

Passenger Car Parks should be reported by the vehicle's owner to his/her insurers and the police

13. Any person parking their vehicle in a Passenger Car Park agrees to indemnify BAL in respect of any claim made by a third party arising out of the negligence of that person

BAL's Rights of Refusal, Detention and Disposal

14. BAL reserves the right to refuse admission to the Passenger Car Parks for any reason
15. BAL reserves the right to detain any vehicle until all outstanding parking charges have been paid (where applicable)
16. Where a vehicle appears to BAL to be abandoned, BAL reserves the right to dispose of the vehicle as it sees fit. If there has been no response within 7 days of formal notice having been sent to the person who appears to be the owner, to pay the charges and remove the car, or after all reasonable steps have been taken to locate the owner of the vehicle, BAL may take action to dispose of the vehicle. If the vehicle is sold, the proceeds of sale will be used to satisfy all sums owed including parking charges, removal and storage fees and reasonable expenses incurred from the sale
17. No vehicle may be towed into the car park nor shall any repairs, renovations, additions or alterations be carried out to any vehicle whilst it is parked in a Passenger Car Park

General

18. No person shall at any time in any Passenger Car Park sell, hire, exhibit for sale or conduct any negotiations or dealings whether legal or illegal or carry out any illegal or immoral acts whatsoever
19. BAL staff have the right to perform their daily duties free from verbal or physical abuse from the users of this facility. Any incidents of this nature will be reported to the police and offenders will be prosecuted
20. Failure to comply with any of the above Terms and Conditions will result in an applicable fee being charged, and may result also in a vehicle being clamped and towed away. Clamped vehicles will be subject to a clamp release fee at the rate applicable at the time
21. Persons using the Passenger Car Parks shall drive carefully and considerately and obey the staff, direction marking, signs and speed limits.
22. References to BAL shall include any representatives, contractors, agents or sub-contractors of BAL and the customer shall mean any person who having control of or driving a vehicle uses the car park and shall include all passengers
